We're proud to share our 2022 results with you. Our second full year of operations was highly focused on joyful program execution and growth with excellence.

In 2022, we nearly tripled the size of our program from 10 to 28 CIPs, successfully expanded to Boston, built and released innovative software for program management and scalability, and recruited a remarkable full-time President and Chief Program Officer, Khalid Cannon.

Looking ahead, in 2023, we plan to increase our program to 50 enrolled CIPs, expand to Minneapolis and Austin, continue improving our software, and explore pilots with corrections systems to unlock scalable and system-changing impact.

MESSAGE FROM OUR CHIEF PROGRAM OFFICER



Dear Supporters of Put Me In!,

I am thrilled to have the opportunity to introduce myself as the President and Chief Program Officer of Put Me In! As a former child of an incarcerated parent (CIP), I know firsthand the unique challenges faced by children growing up with a parent in prison. My personal experience has inspired me to dedicate my career to making a difference in the lives of CIPs.

After graduating from Yale University, where I studied chemistry and geology and played football, I began my career in strategy and value creation consulting for software companies. In 2020, I joined Put Me In! as an early member of the volunteer team supporting our co-founders, Robyn Glaser and Matt Blodgett.

In the fall of 2022, I officially began operating as the first full-time employee of Put Me In!, as President and Chief Program Officer. I am incredibly excited about this opportunity to lead an organization that is making a real difference in the lives of CIPs. In my role, I focus on administering the program on a day-to-day basis while also positioning the organization for future success through our expansion strategy.

Looking ahead, we are committed to continuing our mission of increasing access to sports for children of incarcerated parents. In 2023, we plan to increase total program enrollment to 50 CIPs and add two new cities (Austin & Minneapolis). We could not achieve these goals without the support of our donors and volunteers, who have made our work possible.

WHAT WE DO

We Increase Access to Sports for Children of Incarcerated Parents

Put Me In! breaks down financial barriers faced by system-impacted families through a scalable and efficient model:



Annual financial aid

PMI! provides \$1,000 to each enrollee annually, starting in elementary and middle school through high school



Partnership and collaboration

PMI! finds CIPs and caregivers to enroll through partnerships with other organizations, such as Project Avary in the Bay Area



Covering the costs of sports

PMI! helps system impacted families pay for the costs associated with sports, such as travel, gear, and participation fees



Tech-enabled for scale

PMI!'s financial aid is distributed through a proprietary mobile app and administered through a SaaS platform

Like many parents, Nicole was worried about her son J falling behind, especially after his father's incarceration. As a potential solution, she enrolled J in Put Me In! in 2021.

The results were significant. J began with swimming and later went on to learn Karate -- where he's now up to a purple belt. "I just love seeing how he transforms, and it is such a beautiful growing process because not only is his confidence boosting, his self-worth is growing because he knows if he applies himself, he can accomplish this," J's mom Nicole said.

Beyond increased self-confidence, J's enrollment in Put Me In! has helped generate striking academic improvements -- and he was able to jump at four reading grades in one year. Off the practice field, Nicole has noticed that Put Me In! has honed J's discipline. J's experience is a powerful example of the impact this program can have on students of all backgrounds.
